# Remarks from the Chairman

Arbitration continues to take root as the international tool for facilitating global commerce and attracting international investments across borders and continents. It derives its global commercial appeal from the universality of the regulatory framework established with UNCITRAL. Among the 169 State parties to the New York Convention on the Recognition and Enforcement of Foreign Arbitral Awards, 85 States have fashioned their own national arbitration laws after the UNCITRAL Model Law on International Commercial Arbitration, including the Kingdom of Saudi Arabia.

SCCA embodies the universality of arbitration beginning with its Board of Directors, the third term of which began in March 2021 with member appointments by high order. With all of them leading institutional arbitration experts with diverse backgrounds in terms of specialization, these Board members were brought together to enrich SCCA with their expertise and enhance its international standing in the industry.

SCCA also named new members to its Advisory Committee and its Committee for Administrative Decisions. These new members are high-level international arbitration figures and are part of SCCA's effort to provide ADR services consistent with international standards and best practices. SCCA's Arbitrator and Mediator Roster surpassed 355 arbitrators and mediators encompassing 20 specializations, 24 nationalities, and 19 languages.

The global nature of SCCA Board of Directors, Committees, and Arbitrator and Mediator Roster is also reflected in its caseload and client composition. Since SCCA was founded, the cases registered with it have involved parties with 19 different nationalities.

The ADR industry in Saudi Arabia has not been untouched by the comprehensive efforts to bring industry into line with international standards and best practices. Last year, we witnessed several steps in this regard in the legislative and judicial spheres.

In September 2021, the Judicial Costs Law was enacted, imposing a fee on lawsuits and motions filed in court, with some exceptions. Thereby encouraging parties to consider alternative ways to resolve their disputes and making arbitration more attractive.

More importantly, the law encourages disputing parties to settle amicably in the early stages of a case by reducing or entirely eliminating the fees, which aligns with SCCA's mandate to offer mediation as an ADR option.

Separately, the Council of Ministers also approved the deletion of Article 24(1) of the Arbitration Law, another legislative step that will reinforce institutional arbitration practices in Saudi Arabia that are consistent with international best practices.

In the judicial sphere, figures on the enforcement of local and foreign arbitration awards in Saudi Arabia during 2021 showed promising signs. A total number of enforced awards locally has reached 204 arbitral awards issued in Saudi Arabia and in 12 other countries. The enforced awards total USD 2.1 billion in value, and the enforcement process took an average of 13 days.

Acting in its role of representing Saudi Arabia in arbitration locally and internationally, SCCA announced the results of its study of Saudi judicial caselaw, which showed that of the applications to nullify arbitration awards covered in the study, fewer than 6% were granted. This shows the Saudi Judiciary's commitment to compliance with international practices and the entrenchment of a supportive, arbitration-friendly environment.

All of the above speaks to one clear truth: SCCA is the national beacon for the ADR industry in Saudi Arabia, and year after year it is becoming the preferred international partner in the industry on both a local and regional level.



## Remarks from the CEO

If there is a word to describe SCCA in 2021, it is quality. Quality in performance, quality in service.

Of course, any service provided by any organization is inseparable from the framework within which it is provided. Thus, SCCA has worked in the past year to improve and solidify its framework so all our ADR services will be more accessible to all clients, with our work based on the latest industry standards and practices.

In the past year we have grown SCCA's caseload in number, size, and variety. In 2021 alone, 82 new cases with a total value of USD 555 million were registered. This 587 % annual increase represents 62 % of the total value of cases registered with SCCA since its establishment. This leads us to say that 2021 was a year to match all previous years combined.

In the technical arena, last year the SCCA Board of Directors adopted several amendments to Appendix I of the Arbitration Rules, in order to further enable businesses in all sectors and segments to benefit from the arbitration services we offer. SCCA also launched an improved version of its Online Dispute Resolution (ODR) service – specifically, a new virtual option, with the best procedures and the latest technology, for resolving small-scale commercial disputes quickly and cost-effectively.

Quality has made the most significant impact in advancing SCCA's standing in the industry, as reflected in the collaborative partnerships it has forged with select local and international partners. Among the most important is our partnership with the Permanent Court of Arbitration (PCA) at the Hague to promote arbitration, mediation and other ADR practices, which commenced with the referral of international arbitration cases to SCCA as an appointing authority under the UNCITRAL rules.

SCCA has been placed on the UNCITRAL list of international arbitration centers as one of three Arab centers, and one of 19 centers worldwide, with arbitration rules based on the UNCITRAL rules and which administers cases and acts as an appointing authority in accordance with those rules.


Last year we registered the first SCCA case in which one of the parties is a government entity, a clear sign of confidence in SCCA and its services.

Quality of service and performance is what we rely on, and what we will continue to build on during this year and the years to come in order to make SCCA the preferred regional arbitration partner for all our clients to achieve justice.

## Remarks from the Chief of ADR

2021 has been another successful year driven by excellence, far reaching and impactful initiatives, and record breaking numbers in case filings. The SCCA Secretariat started its year with the addition of high-profile international experts to both the SCCA Rules Advisory Committee and the SCCA Committee for Administrative Decisions. As for SCCA offerings, many have been re-evaluated from the ground up and substantially enhanced.

We started with a call for action to address low-value claims more efficiently with the help of SCCA's state-of-the-art ODR platform backed by an updated ODR Protocol inspired by UNCITRAL's Technical Notes on ODR. Both, re-launched on 7 July 2021, drew much attention in the private and public sector, and led to the first three online filings with awards having been issued in under 37 days.

Another milestone has been the much-anticipated new Appendix I on costs and fees, along with more affordable fee schedules, which entered into force on 1 September 2022. After a comprehensive review, we are proud to now provide our users with more flexible and cost efficient solutions.

We also further enhanced and promoted the use of our mediation offerings by actively pursuing cases pending before courts or being registered in the early stages with government.

Our Emergency Mediation Program (EMP) has been extended and completely upgraded.

Another highlight of the year was SCCA's initiative to collect and analyze over 540 arbitration-related judgements. The findings have exceeded expectations and will help build trust in the judiciary and Saudi Arabia as a reliable, trustworthy and stable arbitral seat. SCCA has also strengthened its collaboration with the judiciary by assisting with the appointment of arbitrators. Finally, a vital indicator for a successful arbitral institution is – at the end of the day – its caseload. SCCA has again seen an increase in its core caseloads, international parties and amounts in dispute exceeding USD 267 million.

As for a brief 2022 outlook, the SCCA Secretariat is particularly excited to finalize – in close cooperation with SCCA's Rules Advisory Committee – its revision of the SCCA Arbitration Rules embracing international best practices. Another highlight will be the implementation of a custom-made software that will benefit clients and personnel alike in even further expediting processes and facilitating the interaction between all stakeholders. Finally, more à-la-carte services will be launched in 2022, including fund holding and management.











## Committee for Administrative Decisions

The Committee is a neutral authority, drawing from the leadership of top institutional arbitration centers, that offers extensive experience to decide disputes arising during arbitration proceedings, both in cases administered by SCCA and those that are not but where the parties submit their issue to resolved by the committee.


